1. Call to Order and Approval of November Minutes

Robert Beltran called the meeting to order. Roll was called, attendees are indicated as above. The December 2013 minutes were approved.

2. Steering Committee Update

Mr. John Shearer was not in attendance. The CFWI Draft RWSP and associated appendices have been finalized and posted to the CFWI website, which will allow for public comments until January 31, 2014. The next Steering Committee Meeting is on February 28, 2014 at the TOHO Water Authority. All meeting information is posted to the CFWI website.

3. Communications Team Update

4. Legislative Update

Ms. Thayer provided a legislative update on proposed water legislative funding. She indicated Senator Simmons has introduced springs legislation with substantial funding associated with the bill. She mentioned Senator Simpson has introduced a bill regarding study of reuse on reclaimed water and a companion bill has also been introduced by Representative Bray.

5. CFWI Regulatory committee Update

Mr. Len Lindahl gave an updated on the regulatory committee. He indicated the water management districts are reviewing the Niagara permit associated with SJRWMD and the Polk permit associated with SFWMD. Both permits will be issued.

Mr. Andy Neff discussed concerns from utilities regarding rule consistency as related to the Water Use Caution Areas (WUCAs) by all the districts. Mr. Tom Beck stated there is a guidance memo that was issued to the Districts. He will forward it to Mr. Neff.

6. SWUCA Update

Mr. Mark Hammond, SWFWMD, provided a presentation on the SWUCA.

Mr. Pat Leahman, Executive Director, Peace River Manasota Water Supply Authority (Authority) also provided a presentation on the Authority's role as related to the SWUCA.

7. 2035 Water Resources Protection & Water Supply Strategies Plan

Mr. Ken Herd provided an outline for the 2035 Water Resources Protection & Water Supply Strategies Plan document. The document outline is based on the Southern Water Use Caution Area (SWUCA) Fiver-Year Assessment document, which is available at: <u>http://www.swfwmd.state.fl.us/projects/swuca/assets/SWUCA_Recovery_Strategy_Assessment_201</u> 3.pdf. Discussion ensued.

8. Sub-Team Update

Discussion was also brought up on providing guidelines for responding to cost/benefits analysis. It was indicated that Mr. Hal Wilkening is currently working on an analysis. Mr. Herd indicated he would contact Mr. Wilkening.

It was agreed all dates would be added to the master schedule and sent to Mr. John Shearer each Friday to update the web information.
